The Partnership for Sustainable Textiles (PST) is committed to a social, ecological, and corruption–free textile and garment industry. Its vision is an industry that respects the rights of all workers, that protects the climate and the environment, and operates with integrity and within planetary boundaries. The Textiles Partnership emphasises the implementation of due diligence in Germany, Europe and worldwide. The work in the PST is aligned with the fundamental international guidelines of the UN, OECD and ILO, as well as corresponding specifications and initiatives on national and EU level.

MEMBERS AND PARTNERS

All actors are needed to manage the transformation towards a socially and ecologically sustainable textile industry. For that reason, around 130 members from business, politics and civil society work together in the Textiles Partnership.

Furthermore, the Partnership for Sustainable Textiles cooperates with international and European initiatives and organisations, among them Sustainable Apparel Coalition, Fair Wear Foundation, Textile Exchange, and Open Supply Hub.

IMPLEMENTING DUE DILIGENCE

Member companies publicly demonstrate on a regular basis how they implement due diligence. With the Review Process, the Textiles Partnership has developed an implementation framework and a reporting format. That entails that companies systematically analyse and prioritise the risks in their supply chains. Based on the assessment, they set targets and derive measures to address these risks and to initiate improvements.

In addition, the PST is in dialogue with other initiatives and standards to avoid duplication and foster harmonisation. For example, it already recognises the report to the Federal Office for Economic Affairs and Export Control (BAFA) under the Supply Chain Due Diligence Act and the report for the Green Button 2.0 as proof of due diligence implementation.

SUPPLY CHAIN TRANSPARENCY

Knowing its own supply chain is crucial for companies to identify grievances, mitigate risks and initiate improvements. Creating transparency right up to the beginning of the supply chain is (still) a challenge for many companies. The Partnership members are taking up this challenge and are gradually bringing more transparency to the deeper supply chain.

The Partnership for Sustainable Textiles publishes an aggregated list of production sites and supplier data of its members at the <u>Open Supply Hub</u>. By those means, the Textiles Partnership contributes to publicly accessible, reliable platform for supply chain information and thus promotes transparency in the industry.
